PhD Degree Program

The Doctor of Philosophy degree is designed for the student who desires to participate at the leading edge of knowledge in the profession of industrial engineering and management. The degree requires the completion of at least 60 credit hours beyond the master's degree or the bachelor's degree. A master's degree is not a pre-requisite for the PhD degree.

Major Milestones & Timeline

- 1. Chair and Advisor Selection (First semester)
- 2. Completion of IEM Doctoral Seminar Course (First year)
- 3. Formation of Advisory Committee (End of first year—start of second year)
- 4. Plan of Study Meeting (End of first year—start of second year)
- 5. Qualifying Exam (Third year)
- 6. Dissertation Proposal and Admission to Doctoral Candidacy (Third or fourth year)
- 7. Doctoral Candidacy Presentation (Within one semester after admission to candidacy)
- 8. Dissertation Review Workshop/Webinar (Within one semester after admission to candidacy)
- 9. Dissertation Defense (Fourth or fifth year)
- 10. Submission of Dissertation to Graduate College (Soon after successful defense)

Chair and Advisor Selection

Typically, the School of IEM matches incoming PhD students based on their stated interest with a "faculty champion" whom we expect will serve both as the research Advisor and committee Chair. Note that these roles could be filled by different faculty members. If the need arises for a change in the Advisor or Chair at any point in time during the period of study, the doctoral student must work closely with the current Advisor/Chair, the Head, and the Graduate Program Director to manage the change.

Selection of the Advisory Committee

The selection of the potential Advisory Committee members should be a collaborative activity between the student and his or her Advisor and Committee Chair. Although the student has the ultimate responsibility for recommending the Advisory Committee membership, his or her Advisor (and Chair, if different) can be a valuable resource with insights that will help the student make informed decisions. The student should meet with potential Advisory Committee members prior to recommending them to better understand their experience, availability, mentoring style, and willingness to serve as an Advisory Committee member. Doctoral students should consult the members of the Advisory Committee frequently and keep them informed on the progress of their work. IEM Doctoral Seminar

The IEM Doctoral Seminar (IEM 6903) is designed to train the doctoral student in the doctoral dissertation research process and is normally taken in the first year of the student's doctoral program. The course will involve significant work outside the classroom, under the supervision of the student's research advisor. The class meetings will be used for some formal instruction on research methods/process, discussion of current research in IEM led by select faculty, guest speakers, presentations by students, etc. The main deliverable is expected to be a "mini" research proposal that the student will develop working closely with their research advisor on a topic that may or may not be related their dissertation research. The student is also expected to make three to four in-class presentations and present the proposal in front of an IEM faculty committee of three including the instructor and the research advisor. The course will also facilitate the development of a preliminary Plan of Study designed to help the student successfully complete the next immediate step in the PhD program.

Plan of Study

The Plan of Study (POS) must include a minimum of 60 graduate credit hours with at least 30 hours of graduate coursework. Courses for graduate credit are selected by the student with the approval of the advisory committee. The Plan of Study must include 3 credit hours of IEM Doctoral Seminar and at least 18 credit hours of dissertation research (IEM 6000). The specific number of credit hours allocated to courses and research, and their timing, is determined by the committee and depends on the student's background and needs to successfully accomplish the research objectives. The post-candidacy reduced enrollment requirements may be leveraged in determining the timing and number of research credits.

Academic Qualifying Exam

A weeklong take-home qualifying exam is given <u>near the completion of the coursework</u> portion of the program. This written and oral exam is used to determine the student's ability to proceed with the research portion of the program. Dissertation Proposal

The student's development of the dissertation topic and proposal should be an ongoing process following the completion of the Plan of Study meeting. The student submits the dissertation proposal to the advisory committee after the successful completion of the academic qualifying examination. This is followed by an oral defense of the proposal. After successful completion of the proposal defense, the student applies to the Graduate College for admission to candidacy. In addition, the student must give a presentation to IEM graduate students and faculty on the topic(s) of their dissertation research as outlined in their research proposal. This presentation must be completed no later than the first regular semester (Fall/Spring) following the student's admission to candidacy. Final Defense

The final oral defense will normally occur no sooner than two weeks after each advisory committee member has received a copy of the student's completed dissertation. The student will give a presentation summarizing the dissertation results in an open session (open to all interested faculty and students) followed by a question and answer session with the advisory committee in a closed session. After successful completion of the dissertation defense, the student prepares the dissertation document for submission to the graduate college. Internship/practicum Credits

The POS may include "IEM 5020 Graduate Engineering Practicum" and "IEM 5030 Engineering Practice" for graduate-level internship/practicum in the field closely related to the student's dissertation topic.

- Students doing a Summer semester internship/practicum must take IEM 5020.
- Students doing a Fall/Spring semester internship/practicum must take IEM 5030.
- A doctoral student may participate in internships in Fall/Spring semesters only after obtaining candidacy and with approval from the advisor, the IEM Graduate Program Director, and the Department Head.
- A doctoral student may participate in internships for maximum two Fall/Spring semesters total.
- The POS may include up to 6 credit hours total of IEM 5020 and IEM 5030.
- The IEM 5020 and IEM 5030 hours cannot be counted towards the minimum 30 credit hours coursework requirement or the minimum 18 credit hours research requirement.
- The student is responsible for meeting full-time enrollment requirements during any semester in which they participate in an internship/practicum.⁵
- International students need to keep their full-time Curricular Practical Training (CPT) under twelve months. Otherwise, they will lose the Optional Practical Training (OPT) option.
